# **EMERGENCY PREPAREDNESS — DAVID BAUM**

If an earthquake struck Bellevue today, our usual sources of water, food, medicine, electricity, natural gas, and communications could disappear in an instant. Red Cross shelters and government assistance would likely not be available for at least 3 days. **David Baum** will make a short presentation about simple, practical things you can do to help you prepare for such an emergency.

## TRANSPORTATION IMPROVEMENTS FOR 148TH AVE NE — JIM BINDER

The City of Redmond is currently implementing the Redmond Intelligent Transportation System (RITS) to increase transportation efficiency in the Overlake area, particularly along 148th Avenue NE and around the corridor, including the Bridle Trails neighborhood.

Intersection improvements and signal timing synchronization at four major locations on 148 Avenue NE are expected to streamline north/south traffic flows. The project along 148th Avenue NE is expected to be on-line within the next five months.
