### BTCC VOTE SEPT. 30 FOR PARK IN OUR AREA – LORETTA LOPEZ

The voter-approved 2008 Park and Natural Areas Levy designated funds for Neighborhood Park Development in the Bridle Trails Neighborhood. The Bridle Trails Community Club created the Park Levy Sub-Committee to work with the City to arrive at an informed recommendation of the preferred Park and Natural Area Levy funded projects in the Bridle Trails Neighborhood. The Park Levy Sub-Committee consisted of seven members from the Bridle Trails Neighborhood. To read about the principles that the Committee followed in developing its recommendation and the details of the process, go the BTCC website at www.bridletrailscommunity.org.

The Bridle Trails Community Club and Park Levy Sub-Committee recommends committing at least \$2.5 million voter approved Parks & Natural Areas Levy funds towards Neighborhood Park Development and Natural Areas in the Bridle Trails Neighborhood. The Preferred Neighborhood Park and Natural Area Development Projects, to the extent projects and development are feasible and can be Levy funded, are identified in preferred order:

- 1. Obtain an agreement with the State of Washington to develop, operate and maintain the property at 5220 132nd Ave NE (aka Acheson property) as a public park.
- 2. Pursue acquisition of the property located at NE 24th and 134th for the purposes of providing Park and Open Space.
- 3. Proceed to develop a Master Plan, with the Bridle Trails Neighborhood and with owners of contiguous property, for a neighborhood public

park at 5220 132nd Ave. NE.

- 4. Proceed to develop a Master Plan, with the Bridle Trails Neighborhood and with owners of contiguous property, for a neighborhood public park at NE 24th and 134<sup>th</sup> Ave. NE.
- 5. Develop a neighborhood public park at 5220 132nd Ave. NE.
- 6. Develop a neighborhood public park at NE 24th and 134th.

We encourage all Bridle Trails Community Club members to attend the general meeting on Thursday, September 30 at the Cherry Crest Elementary School at 7pm and vote.

### KEEPING OUR NEIGHBORHOOD SAFE WHILE ON A BUDGET

The Bridle Trails Community Club strives to keep our neighborhood safe. In April a Cherry Crest resident contacted the City to report that a street light was out. The City did not replace the light bulb due to budget constraints and stated they would not be able to do so until next year. The BTCC got involved and asked for more details about why the City was not addressing this safety problem. Councilmember Jennifer Robertson helped us coordinate with the City Manager to get the light working once again.

If you would like to get involved (please do!) and provide some input to the City budget, there will be a public hearing in October or November. ### **BP/OLYMPIC'S FENCE ON NE 24TH**– NORM HANSEN

After two years of negotiations, BP/ Olympic has installed fencing to screen their pipeline facility on NE 24th. Unfortunately the actual installation was different from the drawings agreed to by the Bridle Trails Community and the Bellevue Parks Department. BP/Olympic made some field modifications due to the elevation changes. They stated that they tried to stay within the plans and drawings but unfortunately they did not consider the elevation changes. Normally fence designers consider changes in elevation because they want the fence to be aesthetically pleasing. BP/Olympic believes the contractor. not the designer, is responsible for any

discrepancies between the plan for the fence and its construction. The City of Bellevue Parks Department is reviewing the installed fence per their requirements since it is on Park Land. BP/Olympic has offered assurances to BTCC that it will work with the contractor to fix the fence.

Since the lumber is still green, BP/ Olympic plans to stain the fence next spring the same color as on the rest of NE 24th.
