## **Detached Accessory Dwelling Units -** Loretta Lopez

The BTCC continues to work on the Detached Accessory Dwelling Unit (ADU) issue. The City may implement zoning changes to allow Detached ADUs in Bellevue neighborhoods that are zoned as single family. The BTCC opposes the changes since the result will be increased density in Bridle Trails and allow rental units on single family property. The City staff plans to appear before the Planning Commission to propose including Detached ADUs as part of the Housing Work Plan for 2012. We do not know the date that the City staff will present its proposal to the Planning Commission. Next Steps: Attend the BTCC November 17 meeting to hear more about Detached ADUs. 

will focus on building a statewide network of "Friends" chapters to help raise funding for our state parks operations – a need that has become critical after the state legislature removed all future funding for parks from the state general fund. These "Friends" chapters will also be set up so they can designate which park should benefit from their efforts rather than those funds being swallowed up in the general fund.

The Washington State Parks Foundation is a 501-c-3 organization that can extend its nonprofit status to "Friends" chapters, thereby saving groups months of start-up work and hundreds of dollars.

## **Bel-Red Development/130<sup>th</sup>** - Loretta Lopez

The City has identified some potential concepts for Goff Creek stream restoration; the planned park ; open space and for a planned urban plaza that will be built along 130th avenue. The City has also identified general time line periods for development that is likely to occur before and after construction of the light rail station. ### **NE 24th Park and Proposed Park at 52nd and 132nd -**Loretta Lopez

The City continues to work on the engineering and wetland studies for the park at NE 24th and 134th. Upon completion, the City will begin the Master Plan Process and ask for public comment. This public comment period may begin in January or February.

## Homeless Encampments in Bridle Trails - Jill Lum

Several neighbors have observed and expressed concern about homeless encampments in our woods, particularly along NE 24th; in Viewpoint Park; on PSE Property; and along the 520 Bike Trail. The Bellevue Police Department has a bicycle unit that regularly rides the 520 trail and tries to stay alert to transients making their homes in our Bridle Trails neighborhood. About two months ago the police removed a large encampment with about 8 people, including tents, cooking materials, garbage and belongings. According to Officer Collins of the Bellevue Police Department Bike Unit, if you observe homeless encampments and would like to report it to the police, the proper procedure is to call 911, and state you are reporting a non -emergency. You can make a report and request a follow up. I have had one report that 911 did not respond because they said there was nothing illegal reported. Please keep in mind that there are No Trespassing Signs posted along NE 24th on the PSE property. Camping in City Parks is also illegal.

## **Notice of Vote in November on Amendment of Change of Bylaws -** Loretta Lopez

The Board of the BTCC recommends that Article IV, Section 5 of the BTCC Bylaws be amended to replace "Scribe" with "Secretary". There will be no other changes to Article IV, Section 5. The reason for the change is to reflect a title which best describes the duties and position. The vote will be conducted at the regularly scheduled BTCC meeting on November 17, 2011. If the membership approves of the amendment the Article IV, Section 5 will state:

SECTION 5. SECRETARY: The SECRETARY shall attend all meetings of the BOARD and the membership and shall keep records and minutes of all such meetings. The SECRETARY shall give, through public notice, or cause to be given, notice of all meetings to each member and the BOARD and shall perform such other duties as may be prescribed by the BOARD or the PRESIDENT. The SECRE-TARY shall also have charge of all correspondence.
