Our Bridle Trails Community Club Comp Plan Task Force of 12 met with Paul Inghram recently to begin developing a vision for Bellevue based on our experience of our neighborhood and rest of the City. We discussed the vitality of the City and Bridle Trails, particularly the high value of open space and tree canopy.

The key elements of the City Comprehensive Plan that we are currently focusing on are:

- Land Use and Housing A key issue is how increased densities affect Bridle Trails. We understand that the City does not plan to add additional residential density to our single family neighborhood.
- Utilities We will look at how we can achieve uniform visual and functional service throughout Bellevue for both City managed and non-City managed utilities.
- Transportation This element is essential not only citywide but also impacts individual neighborhoods. With growth expected in Bel-Red and Redmond's Overlake area, Bridle Trails is interested in the City's Plan to protect the surrounding neighborhood character, especially minimizing cut-through through traffic.

The Task Group will look at other elements and communicate our vision to the City as it develops in scope and details.



Property Search for Bridle Trails Park #2 Loretta Lopez

The BTCC has worked with the City to keep the expenses low on the NE 24th Park. As a result, there are remaining funds allocated from the Park Levy to purchase additional property for Park #2 or open space in the Bridle Trails Area.

The BTCC is forming a Park Acquisition Group (PAG). The purpose of the group is to review property in Bridle Trails that may be available for the City to purchase and create a park or open space. The PAG will review properties and make a recommendation to the BTCC Board. The BTCC Board will then make a recommendation to the General Membership for a vote. Finally, the BTCC will take this recommendation to the Parks Board.

Congregations for the Homeless

The City hosted several meetings facilitating concerned neighbors and representatives from CFTH. There were numerous concerns were voiced and addressed, which opened up a dialogue to develop a plan. One of the most significant action items was that the City and CFTH agreed to host an open house at the property, including requested bios of the men who were living there. BTCC and the City will continue to follow this process, including a follow-up meeting in September to assess the status. In addition, a neighborhood group has formed to raise the issue with the City of continuing to allow these types of facilities in single family neighborhoods. A representative from that group will be attending the general meeting if you would like to join or have questions.

Pike's Peak Water Reservoir Expansion Loretta Lopez

At our March BTCC Meeting, Nav Otal, Director of Utilities, and other Department employees presented information about the Bellevue Water System. While expansion of the tower in Bridle Trails State Park is still in consideration, the Department is re-opening the site selection process and plans to enter into a contract with an engineering firm to conduct a new study to determine where to build or expand a water reservoir in the West Operating Area. The BTCC is following the process to make sure that the City considers factors in the second engineering study that were not considered in the 2010 study. The City anticipates the final site to be selected in early 2014 and construction to begin in 2015.

In addition, the City is considering if it is feasible to move water from the East Operating Area to the West Operating Area, where there is more need.

The Department is developing plans to create a Citizens Advisory Group for this project. The BTCC has asked how the members will be selected, but that has not yet been determined. An outside consulting firm has also been hired to help with community engagement.

The Department is creating a website for tracking the project and answering the questions BTCC members presented at out March BTCC meeting. The project is now called the "West Side Storage Project" The Department hopes to have the website operating by the end of May. The position of the Board of the BTCC

is that the City should not expand the Pike's Peak Water Reservoir since the expansion will adversely affect Bridle Trails State Park.
