Bellevue City Council Member Jared Nieuwenhuis Guest Speaker on May 24th

Attend the BTCC Meeting on May 24 and meet City Council member Jared Nieuwenhuis. Jared was elected to the Council in the November 2017 election. He was a member of the Bellevue Parks Commission prior to being elected to the Council. Jared supports Bellevue neighborhoods.

PSE Project - Loretta Lopez

The City has allowed PSE to segment the transmission line project into a Southern Segment (Somerset area) and a Northern Segment (Lake Hills, Be;-Red and Bridle Trails). PSE filed the application for the Southern Segment in September 2017. PSE has not yet filed an application for the Northern Segment.

The BTCC, working with Coalition of Neighborhoods for Sensible Energy (CENSE), objected to City Staff on PSE's segmentation. The BTCC objects allowing PSE to file 2 applications for 1 project because the result is that there will be 2 hearings, 2 separate reviews by the City Council, and 2 appeals to court. The 2 for 1 approach is a waste of taxpayer money.

The 2 for 1 approach means that BT residents will have to present evidence at Hearing #2 even though Hearing #1 should be where all evidence is presented. This is expensive and time consuming for everyone. Why would the City allow PSE to do this to the residents?
